VENDOR:

1. A damage/Clean-up/Check-out deposit of **\$100.00**, contract and **Certificate of liability insurance (if you are a food vendor)** must be received in advance. We need to have your completed paper work and money and Insurance (if needed) at least 10 working days before the fair opens. The \$100.00 deposit is non-refundable for “no shows or early exit”. A representative of the Fair Association will meet with the vendor before the activity to check all paper work. This will be Marie Layman.

2. Fair and Rodeo food vendors and non-food vendors please put all garbage from your area in a big garbage bag and put it in designated spot. Damage/Clean-up/Check-out deposit check will be returned on Sunday when you check out if area is clean. **DAMAGE/CLEAN UP - CHECKOUT DEPOSIT WILL NOT BE RETURNED IF AREA IS NOT LEFT CLEAN AND IF YOU DO NOT CHECK OUT WITH MARIE BEFORE LEAVING ON SUNDAY.**

3. If you are a food Vendor, you must provide a certificate of insurance (RELEASE OF LIABILITY) in the amount of \$1,000,000.00 and naming the Fair Association. The Association will not be responsible for loss, damage or injuries.

4. The Fair Association will not be responsible for extra preparation and/or equipment for the vendor's activities.

5. If you are a food vendor, you need a Stevens County Food Vendor Permit. For more information call Stevens County at 509-684-2262 or 1-800-776-6207.

6. If you are a food vendor, you must have a valid Washington state Health Card.

7. **All vendors need to have a fire extinguisher in your area: (A B C type)**

8. If you need more than 1-12x12 slot it will be considered two slots or 3 slots etc. Please indicate how many slots you need: _____

9. There is a Royalty Luncheon provided for the Royalty & Families only. On Sunday at 11:30 am.

10. There is no smoking on fairgrounds except in designated areas.

11. Vendors may not distribute handouts outside of their space.

Friday 10:00 a.m. to 6:00 p.m.

Saturday 10:00 a.m. to 6:00 p.m.

Sunday 10:00 a.m. to 3:00 p.m.

You may open before this time if you would like, but cannot close earlier than time posted unless O.K.'d by vendor supervisor.
